BRAINSTORMING AT THE MTNA

The MTNA Leadership Summit was held from September 11-13, 2016, in Cincinnati, Ohio. In addition to providing up-to-date information about the workings of MTNA, the Summit offers state leaders the opportunity to brainstorm and exchange ideas. We had the opportunity to meet the various MTNA Chairs. Membership retention is an issue for all states and the good news is that WMTA is in the top echelons for retaining membership. In terms of certification, we rank among the lowest, simply because many of our members also belong to other state organizations and certification is only counted in the "home state." Therefore, only our certified members who reside in the Washington, D.C., area are counted for our state.

The FTC compliance agreement was once again discussed. The main impetus of the discussion boiled down to two "commandments:" (1) Thou shalt not prohibit or restrict the recruitment of students and (2) Thou shalt not discuss prices among yourselves.

We were given a financial presentation of MTNA. The organization is in good shape financially and the audit provided no material problems.

MTNA has moved to a new headquarters across the street from where they were previously. The rent per square foot is less but they do have more space now, including a new recital room. The new space is lovely but the spectacular views of the Ohio River that they had in the old

There were meetings of states by size. States similar to our group were AR, DC, MT, ND, NM, SD, and WV. There was also a meeting of the Eastern Division. One interesting fact was that some states do joint conferences. And all the states encourage members from other states to attend, so since WMTA does not do a separate conference, members would be welcome to explore and attend conferences in neighboring states.

MTNA is working on improving and expanding their website to include features like webinars.

The Steinway Piano Company has changed the award it offers to the Young Artist winner from a grand piano to a \$5,000 cash award. The logistics of shipping the piano were becoming cost prohibitive.

And please note the MTNA National Conference in 2017 will be held in Baltimore, MD, right on our doorstep!

In October, I attended a Shop Talk at Barbara Wing's studio. Again, this was a chance to exchange ideas, but on the teacher-to-teacher level. The focus this time was on early level repertoire and how to determine levels. In December, the topic for discussion will be how to prepare

students for college-level music study, including a timeline of what you need to do from the early levels forward. I would encourage all WMTA members to take advantage of this free resource on Thursdays in the early afternoon. Check the WMTA calendar for future dates.

Although we still have a work requirement for all members entering students in WMTA events, at the board meeting last June, we voted to allow members to use a substitute for one event per year. The substitute must be a member of WMTA in the same field of study. The Chair must be notified of any substitutions.

Please remind the parents of all your students that videotaping is permitted at WMTA events but only of their own child.

We had an incident of a parent videotaping the child of another family who was playing the same piece. This could disqualify their

child. It is against WMTA rules, so please avoid this potential disappointment and give your parents this gentle reminder.

And I would encourage all WMTA members to review the rules that are posted on the WMTA website.

We are working to improve the WMTA website. Did you know there is a "Members-Only" section where you can download a printable directory of WMTA members? Your initial login is your last name and membership number. Don't know your membership number? You can just click on the link to have it emailed to you.

And don't forget about the WMTA listserv. This is the forum where you can get information about discounts for WMTA members, job postings, and any other information sent to us that does not directly relate to WMTA business but might be of interest to members.

BARTOK COMPETITION TO BE HELD JANUARY 30

The bi-annual Bartok Piano Competition (http://www.wmta-dc.org/pdfs/

Bartok.pdf) will be held January 30, 2016, in the National Presbyterian Church at 4101 Nebraska Avenue, Washington, D.C. Application fee is \$25. Only online registration is available. Deadline for the all day competition was December

Honorable Mentions may also be awarded. All students will receive critiques and certificates.

The competition is held in recital form. Students through the 12th grade are eligible to enter. Each student is assigned to a recital group and

should arrive 15-20 minutes before the start of their group. Those who arrive late or do not stay for their entire session will play for comments

Students must provide the judges with scores of their pieces. All partici-



pants must comply with U.S. copyright law. For use of copied or downloaded materials, please refer to the

WMTA General Rules. Teachers of

participating students should be prepared to help on the day of the competition. If a teacher is unable to help, please refer to the WMTA rules regarding the use of a substitute for one event. The Chairperson $\,$ For Children, Vol. I # 26, Moderato \mathbf{OR} must give prior approval for any $\,$ For Children, Vol. II $\#35,\,Ballad$ substitute.

Repertoire requirements: All pieces by Bartok. Boosey & Hawkes editions are recommended but not required. One selection from the required list plus any piece or pieces of the student's choice.

Students may play any number of pieces as long as they do not exceed the time limit. Pieces from any

required list may not be used as choice pieces.
